

# SUBLETTE CENTER AND HOSPITAL DISTRICT MERGE

After 45 years, the Sublette Center has joined forces with the Sublette County Hospital District to enhance senior care services in our community. The historic merger brings new opportunities and resources for both organizations, uniting healthcare under one umbrella.

On Dec. 20, the Sublette Center board adjourned for the last time. Present were Chair Patty Racich and members Nancy Guio, Ruth Steel, Marilyn Jensen and Kerry Majhanovich, along with Hospital Board members - Kenda Tanner, Tonia Hoffman, Dave Bell, and Ashli Tatro.

Moving forward, the operations of the Sublette Center and the Hospital District will largely remain the same with the Interim Administrator Lindsey Bond leading the Hospital District and Administrator Dawn Walker leading the Sublette Center. Together, they fully expect to maintain the familiarity that the community has come to appreciate with the Sublette Center.

“We want to preserve the essence of what has made the Sublette Center special while providing resources and support from the Hospital District,” Bond said.

# 2023 PROGRESS REPORT

Over the last year, the Sublette County Hospital District (SCHD) has accomplished many necessary steps to build the hospital and new long-term care center.

**JANUARY 31**

## CONSTRUCTION BUDGET SHORTFALL

Inflation, a sharp increase in construction costs, and a robust commercial construction market caused a \$9.2 million shortfall in the construction budget. After exhausting all alternatives, the SCHD Board returned to the county commissioners for help. The district had already raised \$66 million, or 88% of the project cost, through grants, loans, a pledge from the county and other revenue sources.

**FEBRUARY 21**

## \$1 MILLION DONATION BY JOE RICKETTS

Joe Ricketts, owner of Jackson Fork Ranch, donated \$1 million to Sublette County Health Foundation to help close the funding gap and avoid a potential construction delay.

**FEBRUARY 24**

## COUNTY COMMITS ANOTHER \$5.4 MILLION

The Sublette County Commissioners committed an additional \$5.4 million towards the Gross Maximum Price (GMP) for project construction.

**APRIL 7**

## COMMISSIONERS REVIEW BUDGET

Owners Representative Karl Lueschow and Layton Construction VP Jeremy Hobbs presented the construction budget to the county commissioners.

**APRIL 18**

## SCHD BOARD ACCEPTS PRICE OF \$57.7 MILLION

The SCHD Board accepted a Gross Maximum Price (GMP) of \$57.7 million from Layton Construction. Lueschow stated that the construction budget carries little risk.

**JULY 10**

## CONSTRUCTION UNDERWAY!

Tractors, excavators, and dump trucks rolled onto the site of the future hospital and long-term care facility and started dirt work. Local contractors Teletractors, Premier Site Development, and Wind River Concrete are all part of the construction team.



**AUGUST 3**

**EXPANDED HOURS AT MARBLETON/BIG PINEY CLINIC**

In the interest of improving access to healthcare in Marbleton and Big Piney, the district expanded the clinic’s hours.

**AUGUST 17**

**DR. ANDRAS EDER JOINS SCHD TEAM**

SCHD welcomed Dr. Andras Eder, a board-certified physician in family medicine. Born in Budapest and growing up in Ohio, Dr. Eder served in the U.S. Navy as a Hospital Corpsman.

**AUGUST 31**

**2 PHYSICIAN ASSISTANTS JOIN EMERGENCY DEPT.**

Kelsey Wagner, PA-C and Noah Chutz, PA-C join the SCHD team. Noah is a graduate of the University of Washington and a returned Peace Corps volunteer from Mexico. Kelsey has a degree in sports medicine, graduated with her PA from the Heritage University, and did her internship in Cheyenne.

**OCTOBER 19**

**BOND APPOINTED INTERIM HOSPITAL ADMINISTRATOR**

Dave Doorn, Administrator for the Hospital District since 2021, resigned his position and moved to Montana. Lindsey Bond is promoted to Interim Administrator.

**NOVEMBER 2**

**SCHD BOARD MAKES CHANGES**

The board approved the purchase of a 2022 Dodge ambulance to address concerns about the aging fleet. Katie Hoffman is named Sublette Center Director of Nursing. The board also instituted a wage increase to remain competitive and to retain quality providers and staff. Finally, the board approved launching a nationwide CEO search.

**DECEMBER 11**

**STAR VALLEY HEALTH CONTRACT ENDS**

The SCHD board voted unanimously to end the management contract with Star Valley Health and mutually part ways. The board started to solicit new proposals for new management or consultant services to guide the process of opening the critical access hospital.

**DECEMBER 20**

**SUBLETTE CENTER MERGES WITH HOSPITAL**

This marked the final board meeting of the Sublette Center with their nonprofit board. The Sublette Center merged into the Hospital District on Dec. 31. The employees look forward to increased benefits such as Wyoming Retirement.

## QUICK FISCAL OVERVIEW



**TOTAL REVENUE INCREASED BY 65%.**

- ↑ Saw an increase revenue from Pinedale Medical Clinic (10%), mill levy (155%), and grant funding (81%)
- ↓ Had a decrease in revenue from Emergency Medical Services (-17%) and Marbleton/Big Piney Medical Clinic (-5%), as well as a less funding from Health Resources and Services Administration (HRSA) COVID-19 (-77%) and Federal Emergency Management Agency (-59%)



**TOTAL EXPENSES INCREASED BY 20%.**

Saw a 15% increase in employee wages and 54% increase in medications, supplies, insurance, utilities, and other costs

## FOCUSING ON QUALITY PATIENT CARE . . .

**The goal of a healthcare system is for the patient to receive the best possible care.**

A healthcare quality department is in charge of ensuring that quality healthcare is being administered to all patients. The department is also in charge of managing risk, ensuring compliance, preventing infection, and improving overall performance.

After the patient's visit, quality management teams measure data, including adverse events, patient outcomes, and experience, to optimize future care and make changes and recommendations as needed.


## IMPROVING PATIENT CARE

As part of an ongoing effort to continue to improve patient care, SCHD instituted patient satisfaction surveys with the nationally renowned company Press Ganey. The first quarter of surveys showed an 81% positive rating in Pinedale Medical Clinic, Marbleton/Big Piney Medical Clinic, and the Emergency Services Department. The data from these surveys is being used to improve the quality of service in many areas, including waiting times, moving through a patient's visit, and being sure employees properly introduce themselves at every encounter.

# SUBLETTE COUNTY HEALTH CONSTRUCTION

**Construction started in July 2023 and is expected to be completed March 2025.**

Layton Construction is a national firm that has completed dozens of healthcare projects each year around the country. They have also worked locally, having built the beloved Pinedale Elementary School in 2010.

- ▶ The new hospital facility will consist of a 10-bed inpatient unit plus a pharmacy and laboratory with blood bank. The facility will also have advanced imaging capabilities, including ultrasound, DEXA, X-Ray, CT, Mammogram and MRI.
- ▶ The 50-bed skilled nursing facility will include a 10-bed memory care unit. Each room in the new facility will have a bathroom and shower. Unlike the current facility where most of the rooms are doubles, requiring the patients to have a roommate, most rooms in the new facility are private.



# OUR FOUNDATION

## CAPITAL CAMPAIGN

The foundation has raised \$4.18 million in 2023. Fundraising for 2024 is \$1.25 million to date.

Donations include: \$3.78 million for Phase I of the capital campaign, \$1 million for the Gross Maximum Price (GMP) from local Joe Ricketts, \$400,000 for the Women’s Health Initiative, and \$200,000 for Emergency Room beds and nurse call.


